DETERMINATION OF HIGHER EDUCATION PROGRAMME FEES 2020/21

1. Purpose

- 1.1 To ensure that fees charged to learners comply with the rates approved by the Corporation Board.
- 1.2 To ensure that the fees are constructed so as to meet the requirements of external bodies.

2. Applies to

2.1 Programmes for which a fee is levied.

3. Responsibilities

3.1 **Vice Principal Group Organisation:** Recommending fee levels to the Corporation Board via the Chief Executive Officer (CEO).

4. Processes and Documentation

A number of elements may contribute to the overall amount charged to a learner. Some will be charged at enrolment and some during the programme. These may include, but are not limited to:

- a. Tuition fee
- b. Materials and consumables
- c. Examination fees
- d. Residential fees
- e. Educational visits and other off-site activities
- f. Other fees
- 4.1 In the spring term, the Head of Higher Education will consult with the VP Quality and Curriculum and VP Group Organisation who will in turn consult with the Executive Leadership Team and recommend the levels of HE fees for the following year to the Finance and Resource Committee and the Corporation Board. Once approved, the VP Group Organisation will disseminate this information with the Head of Higher Education.
- 4.2 This figure will be used in the Student Record System, ProSolution, and subsequently in the fee analysis on the enrolment forms (paper only).

Higher Education Fees

- 1. This refers to all of the College's HE programmes, including any that retain funding, directly or indirectly, from the Office for Students.

^{*}End-on programmes do not include any other combinations of programmes such as:

- Learners with a HNC topping up to a HND/Fd.
- Learners taking a higher level programme after completing a lower level programme where the mode of study changes (e.g. the learner takes a part-time honours degree top up programme after completing a full time HND/Fd). The College will offer some flexibility to this rule because we do not offer full time and part time routes for all of our programmes. Therefore, if a learner is forced to

change mode of attendance for the top up programme, due to the colleges delivery restrictions, the learner will not be penalised and may retain the existing tuition fee charge of the first programme.

After having completed L5 of a HND/Fd within the Cornwall College Group a learner may progress directly onto a L6 qualification and retain the same tuition fee as for their previous L5 qualification providing there is no change in mode of study to the L6 programme that offers both full-time and part-time routes.

Note that for all learners in receipt of a tuition fee loan, fees are paid to the College by the Student Loans Company.

Self-funding

For learners who are not in receipt of a tuition fee loan, the College will request that 25% of the annual tuition fee be paid at the start of the academic year and the remaining balance paid equally via monthly direct debit). Student network accounts will not be activated nor will students be registered with respective awarding bodies until this initial payment has been made. ID cards will also be withheld.

Repeating Studies

3. Learners who are required to repeat failed modules with attendance will be charged the pro-rata module rate, based on their existing annual tuition fee. Learners with valid extenuating circumstances will not be charged.

Resuming Studies

4. When a Learner suspends study the college retains 25%, 50% or 100% of their annual tuition fee depending on their date of suspension (as described in the *Withdrawing and Suspending Study* section). This is to cover the cost of teaching the learner prior to their suspension.

The fee a learner is charged when they resume studies depends on whether they suspended due to valid extenuating circumstances or not:

- If a learner suspended without valid extenuating circumstances, they will be required to pay for modules they did not complete and achieve prior to suspension. These learners will retain their existing tuition fee charge and will be charged the pro-rata module rate. E.g. a learner was charged an annual tuition fee of £8,600 (£1,433.33 per 20 credits). When the learner resumes study they will be required to study 80 credits. The tuition fee they would pay to resume would be £5,733.33 (£1433.33 x 4 = £5,733.33).
- If a learner suspended with extenuating circumstances they would retain their original tuition fee charges. The resuming fee would be based on what their original annual tuition fee was, minus the suspension fee. For example, a learner was charged an annual tuition fee of £8,600. TCCG retained £4,300 of this when they suspended studies. When they resume studies, they will be required to pay the outstanding balance of £4,300.

• If a learner suspends on more than one occasion, the resuming fee they will pay will be based on whether their last period of suspension was due to valid extenuating circumstances.

Transferring Studies (Same Mode of Attendance)

5. Learners that transfer to another programme within Cornwall College in 2020/21 will retain their existing student support and tuition charge arrangements (provided they are not changing mode of attendance).

For example:

A learner enrols on the full-time FdA Event Management in September 2020 and is charged £8,600 for the 2020/21 academic year. After term one, the learner decides they wish to transfer to the full-time BA (Hons) Business Enterprise Management. As programme transfers cannot take place after 31st October, the learner must apply for the BA (Hons) Business Enterprise Management through UCAS for the following academic year. The learner may either continue to study the FdA Event Management in 2020/21, withdraw or suspend studies. If the learner decides to suspend studies, the tuition fee they are required to pay should be calculated based on section 5 of this procedure. If the learner is accepted onto the BA (Hons) Business Enterprise Management in 2020/21, they will be expected to pay the 2020/21 fee of £8,600. If the learner chooses to withdraw from the FdA Event Management they will join the BA (Hons) Business Enterprise Management on the respective tuition fee set for 2020/21.

Transferring Studies (Different Mode of Attendance)

6. Learners that transfer to a programme within Cornwall College then change mode of attendance should be charged the new fee for the academic year in which they commence the new mode of attendance. Please note: Students wishing to change their mode of attendance from part-time to full-time must do so by the 1st October of their first year. This date is earlier in the academic year due to the tuition fee payment from the Student Loan Company.

For example:

A learner enrols on the full-time FdSc Marine Science in September 2020 and is charged £8,600 for the 2020/21 academic year. At the end of the 2020/21 academic year, they wish to transfer to the part-time FdSc Marine Science. They commence the part-time Mode of Attendance in 2020/21, and therefore charged the new part-time fee for 2020/21.

In exceptional cases a learner may be permitted to transfer from full-time to part-time during the academic year. In order to calculate a revised fee for this learner you must:

- a. Calculate the full-time fee for the terms studied full- time during the year of the transfer. To do this, take the yearly fee, divide this by 3, and then multiply this by the amount of terms studied at full-time. (If a learner transfers mid-term, they will be charged the full-time rate for the entire term).
- b. Calculate the part-time fee for the terms that will be studied part-time during the year of the transfer. To do this, take the part-time yearly rate (this should be the new part-time fee that is in place for the year the transfer is taking place), divide this by 3, and then multiply this by the amount of terms to be studied at part-time.
- c. Add these two figures together to get revised fee for the year of the transfer.

d. The learner would then pay the yearly part-time fee for the remainder of the programme.

Learners with Extenuating Circumstances

Learners who transfer to a different mode of attendance due to valid extenuating circumstances will retain their existing student support and tuition charge arrangements.

Transferring into Cornwall College

7. Learners who enrol and attend a HE programme at another institution in the 2020/21 academic year, and subsequently transfer to Cornwall College within the 2020/21 academic year, will be classed as a 'Late Transfer', as defined in the HE Enrolment Procedure.

If the learner is funded by the Student Loan Company, the original institution may retain 25% of the student loan. If the College is unable to recoup this 25% from the institution, the learner will only be liable to pay the college the remaining 75%.

If the learner is paying their own tuition fees, they will be required to pay the full annual tuition-fee (25% and the remaining balance paid via direct debit).

If the learner wishes to claim Accredited Prior Learning, then their tuition fee will need to be adjusted to reflect this.

Late Starters

8. Learners classified as late starters as per the HE Enrolment Procedure (i.e. learner who has not transferred in from another institution) will be charged the full annual tuition fee. Late starters who wish to claim Accredited Prior Learning should only be charged for the modules they are actually studying, plus the APL fee as described in paragraph 3.

Withdrawing and Suspending Studies

9. Learners that withdraw from a programme and begin a new programme on or after 1 September 2020 will be deemed to be a new learner and will adopt the new tuition fee for the academic year in which the learner commences study.

The College will operate the following fee refund policy for undergraduate or postgraduate taught learners who withdraw or suspend their studies:

All students applying for Student Finance must have their application in place when they commence studies in September, enrolment may be withheld until evidence has been provided. Late starters must also adhere to the above and provide evidence of application if approval has not been received.
